Instructions:

- Copy this form as necessary.
- Complete one form for each pony nominated.
- Attach a copy of the Nominee's ACPS Registration Certificate to each form.
- Indicate site of preference. No pony will be officially nominated until the nomination, fees, and other required papers have been received by Marynell Eyles.
- Submit all paperwork and fees by advertised deadline for your preferred site.
- The VETERINARIAN'S INSPECTION REPORT FORM can be downloaded from the ACPS web site or requested from the Inspection Chairman. This document must be completed prior to inspection date. Note that the veterinarian must measure the pony. ON INSPECTION DAY, THE VET REPORT FORM AND THE PONY'S PERMANENT REGISTRATION PAPERS MUST BE PRESENTED WITH THE PONY.

What ponies are eligible - All Connemaras, domestic or imported, with a TFC or ACPS permanent registration. Connemaras presented for Inspection should conform in breed type and conformation to the ACPS Standard. The minimum age for eligible ponies is 2 years.
