Document Name: Registration Fees

## ACPS Fees for Members: *Fees are doubled for non-members*

### Temporary Foal Certificates , TFC (Application ACPS-F02)

*Purebreds: Within 6 months of birth (includes DNA sample kit) \$ 50*

*Purebreds: After 6 months to 2 years \$ 60*

### Permanent Registrations

*With a Temporary Foal Certificate (TFC) \$ 30*

*Purebred without a TFC \$100*

*Stallions, 2 years, \$250 (blue-eyed cream colts and halfbreds are not eligible for registration as stallions)*

*Stallions, 3 years or older \$500 (\$250 plus a \$250 late fee)*

- Cost of DNA kit and testing are included in the stallion registration fee.
- Rebate for gelding a stallion: \$200 rebate available to stallion owners who send proof of castration, signed by veterinarian, to Registrar. No age limitations.

### Halfbred Registrations:

*One-time fee: \$50 for members/double for non-members.*

*Use the temporary foal certificate form and mark the box for Halfbred.*

*The ACPS does not register halfbred stallions or blue eyed cream stallions.*

### Transfer Of Ownership

*Within 30 days of date of sale \$25*

*After 30 days \$35*

*The seller is responsible for completing the transfer papers and is encouraged to give a Magazine subscription to the new owner.*

### Transfer Of Imports

*Imports between age 6 mos. and 2 yrs. (with TFC from another country) \$30*

*Any age, within 1 year of arrival \$ 30*

*Imported Stallions, registered in another country \$250 (Cost of DNA kit and testing are included).*

### Farm Registration (Application ACPS-F03) \$100

DNA Testing Kit \$ 40

Name Change \$ 100 (Prefixes may not be changed or dropped without the breeder's written permission)

Extended Pedigree \$ 20

Duplicate Certificate \$ 50 – Issued to last recorded owner only

Individual Stud Books (XXX-XXXVII) \$ 15

Collaborative Stud Book I-XXX (1-30) \$ 60
